JOB DESCRIPTION

CARE FARM SUPPORT WORKER (P/T 15 hrs – Thursday and Fridays) – permanent £ 6357.00 per annum

Main Purpose

The role of the care farm support worker is to enable our farm helpers to carry out activities on the farm, ensuring they achieve individual goals

Position

The Care Farm Support Worker will report directly to the and Care Farm Manager

Duties

1. To identify activities and assist farm helpers in their tasks on the farm and encourage enable them to carry out a task appropriate to their ability.
2. To enable farm helpers to act appropriately and treat others with respect according to the code of conduct
3. To encourage farm helpers to work towards their individual goals.
4. To take on a 'key work' role for individual farm helpers which includes liaising with cares, other professionals and attending reviews.
5. To provide a work environment where farm helpers feel included and part of the farm and its activities.
6. To keep professional boundaries in relation to farmhelpers, staff, volunteers and visitors.at all times
7. To ensure farm helper's safety and adhere to health & safety regulations
8. To support volunteers through a mentoring scheme

9. To ensure that the market garden, grazing land and animals are well looked after to a high standard and good farming practice.
10. Use tools, agricultural/horticultural machinery and vehicles such as small tractors with appliances, mowers, strimmers, hedge cutters etc and to support farm helpers in using these tools and equipment.
11. To undertake appropriate learning and development as identified through the appraisal and review process.
12. To write reports, to maintain records and use IT where needed.
13. Maintain and keep equipment safe & clean and store in an appropriate location. To report any faults or safety issues.
14. To adhere to Clinks Care Farm Ltd. policies and procedures, in particular Health & Safety, Safeguarding policies and equal opportunities policy.
15. To carry out any related duties as and when required.
